In the Name of Goden Amen. I Robert Smith of Coxwold in the N.R. of the County of York Gentleman do appoint this to be my last Will and Testament in manner and form as follows

I give and bequeath to my brother Thomas Smith of Wildon Grange Farmer and to my nephew Joseph Smith of Risebro Farmer and my son William Smith of Coxwold Station Master All my share of leasehold tithes and Glebe lands in the Parishes of Coxwold and Husthwaite & elsewhere

And all my other property & effects that I now or might hereafter possess of whatever kind or description In trust for the following purposes My will is that all my just debts funeral & testamentary expenses should be paid as soon as convenient and for that purpose I empower the said trustees to borrow money on security of my tithes or to sell all or any part of my cattle fodder implements & ??? shares as they may deem advisable

My will then is that my wife Dorothy have paid her yearly (by two equal half yearly instalments) during her life the income arising from my tithes or any other source whatsoever after first paying or reserving for payment all interest monies and other charges which do or may hereafter arise therein

My will is that my wife also have for her own use & benefit all or any remaining part of my cattle fodder fixtures books & furniture or any other article whatsoever as long as she shall live

My will is that at her decease my trustees should if they think proper sell all my interest in the tithes all my stock furniture or any effect whatsoever that may remain at the death of my wife and after paying all my debts & legal expenses pay at 12 months after her death to my grandson Frederick Dempster Smith (son of my late son John) the sum of fifty pounds and pay to my sons Joseph George & William Smith the remainder of the proceeds of each sale in the following proportions ??? that George & William have each the double amount of Joseph and that the amount to be paid to Joseph be invested and the interest therefrom be paid him by my trustees in equal weekly instalments

My will is that if it is inconvenient or if it appear to my said trustees not advisable to sell the whole or any part of the said tithes stock and furniture, that my sons named shall continue to receive the income arising therefrom in the same proportions named i.e. George and William shall receive double the amount of Joseph and that Joseph's share be paid in equal weekly instalments

My will is that if any of my sons or grandson named die without lawful issue before their legacies are paid that the survivors or their lawful issue have equally divided amongst them the deceased share, Should any of my sons or grandson die leaving lawful issue my will is that each one should have paid them for their maintenance and education their father's share until the youngest of that family arrive all the age of 21 years Then their father's share to be paid them in equal proportions And I hereby nominate constitute and appoint the said Thomas Joseph and William Smith to be the Executors of this my last Will and Testament In Witness thereof I hereto subscribe my name this 16th day September in the year of our Lord one thousand eight hundred and sixty three

Joseph was part of the organising committee for the expedition, under the leadership of his son-in-law, Henry Boast. Following the untimely death of Henry in May 1850, Joseph made a significant financial contribution to the expedition (about £800) and then took on the leadership of the party.

Extract from the book "Memoirs of Joseph Smith", son of John Smith, where Joseph writes about his father:

John Smith and his brothers, were the lessees of the tithes owned by the Trinity College, Cambridge, in the parishes of Coxwold, Husthwaite, Oulston, Yearsley, Carlton, etc., and having in their hands the gift of the ecclesiastical living of Coxwold.

In the year 1821 he entered into the marriage state, and lived four years upon an adjoining farm to that of his father's at Wildon Grange, from which he removed to Osgoodby, about three miles distant where he lived six years, and continued his attentions to the means of grace and the Sabbath school at Kilburn. During his residence at Osgoodby he suffered under a severe dispensation of God's providence, by losing his sight in the right eye, which was caused by the lash of a thorn. His sufferings were excruciating. The brain, because of its intimate connection with the eye, became feverish and delirious. He was reduced to a skeleton, but God in

His mercy restored him to health of body though he continued quite blind in that eye to his death. However, God sanctified this affliction. He came out of the furnamce a new man. The change was perceptible, and remarked by all his friends; his piety assumed a more settled and solid character and his anxiety to do good became more and more manifest. In the year 1831, he and his family left Osgoodby in the Easingwold circuit, and came to reside at Normanby, in the Pickering circuit, where he found religion but little known and practised. There were no means of grace in connection with Wesleyan Methodism; but as there was a little chapel built by a private individual, he soon commenced prayer-meetings and secured regular preaching. A small Society was formed, over which he was appointed leader. Its numbers gradually increased until he left in the spring of the year 1848, when he left two flourishing classes. In the spring of 1848, after having settled a part of his family in the neighbourhood, he removed to Oulston, in the Easingwold circuit. After having spent seventeen years at Normanby, he was anxious to return to the neighbourhood of his early days, to mingle with his numerous relatives, and spend his declining days amongst them. Some time previous to his removal from Normanby, he felt that some of the pins of life were becoming loose, but his activity was unabated, and it was not till a few weeks before his death that any fearful apprehensions as to his life were entertained.

About the latter part of November, 1848, when on a visit to Normanby, his horse fell with him in the gig. He was thrown out and severely bruised; and though he so far recovered as to feel nearly free from pain, yet the effect was such as to feel nearly free from pain, yet the effect was such as undoubtedly to hasten the end.

On Saturday December 30th, a week after he was confined to his room, he was visited by the usual number of friends. He seemed to have uncommon power to converse; his mind seemed to possess unusual strength and clearness; his replies to the numerous questions put to him were remarkabley clear and pointed; the quotations from scripture and our beautiful hymns were appropriate, striking, and numerous. When asked if he was harrassed by temptation, his reply was, that he was in better hands than to be tempted. "In my weak state I have not strength to combat the enemy, therefore my God, whom I serve, will not suffer me to be tempted." When a friend remarked to him that God dealt with him better than he did with his brother William, who instantly expired two or three years before, and his brother in law, Mr Rimmington, who had died a few months before, who only had a short affliction, and was scarcely able to express himself any of the time, he replied: "They were quite ready for their change, but that it was necessary for God to put me in the furnace to be purified and made ready to join them."

The clock had not long announced the hour of five on the Wednesday morning of January 3rd, 1849, when the curtain of life was let down, and his happy spirit took its flight to Paradise. On the Saturday, at twelve o'clock, the last debt of nature to him was paid by depositing his remains in Coxwold churchyard, in a sure and certain hope of a glorious resurrection, when they shall again be re-united to the sould to spend an eternity of happiness together.

Thomas was born less than 3 months after the death of his older brother of the same name, so this is probably the reason he was given the name Thomas.

At the time of marriage, Elizabeth Fawcett was living with her brother John, at Osqoodby.

Thomas and his brothers were Methodists and along with his older brother William, he had significant financial input when the Methodist Chapel at Kilburn was built. They also sent their farm labourers to dig foundations and act as labourers for the builders.

In later life he got himself into an unfortunate financial situation as he became involved in a business partnership where the partner defaulted on all his debts, which meant that Thomas was then liable for his partners debts. This more or less bankrupt him and was such a shock that he died soon afterwards, leaving his son Joseph to clear his debts.
