#### NOTES:

Info from Lancashire Record Office (Preston) indicates that Liverpool Trade Directory for 1898 states that his firm was "Grace, Smith & Hood" whose offices were at 35 Castle Street, Liverpool. It is not entirely clear from the directory but the implication is that 37 Falkner Square was his home.

#### LAST WILL & TESTAMENT (1925):

This is the Last Will and Testament of me FREDERICK DEMPSTER-SMITH of the Hotel Victoria in the City of Westminster. I revoke all Wills and

testamentary dispositions heretofore made by me and declare this to be my last Will and Testament.

I appoint MAJOR THE REVEREND OSWALD LUNN MARTIN of the Temple Church Bristol to be the sole Executor of this my Will.

I give to the Governors of St Bartholomews Hospital the sum of Twenty five thousand pounds for the endowment of a Ward at such Hospital to be named and kept in perpetuity as having been founded by me in memory of my late dear friend WILLIAM JAMES MARRIAGE ( "Sol" ) a Corporal Major in the Household Battalion who was killed in France while serving his Country in the Great War, such Ward to be called "The Sol Memorial Ward" and I declare that the receipt of the Treasurer for the time being of the said Hospital shall be a good discharge to my Executor for the amount of the said legacy. And I further declare that in case my friend Claud Baker Gabb of 167 Victoria Street Westminster shall be living at the time of my death it is my wish that he should be consulted in connection with any details in reference to this bequest as he is much interested therein and knows my views in reference thereto.

To PRINCESS MARIE LOUISE HENRIETTE JOSEPHINE OF BOURBON formerly DUCHESS OF SEVILLE the sum of Five thousand pounds begging Her Royal Highness' gracious acceptance of such sum as a slight token of gratitude for her unvarying kindness consideration and sympathy to me and my family for so many years past.

I give to ELIZA JANE SMITH of Cliff House, Filey, in the County of Yorks the sum of Three thousand pounds and to the said OSWALD LUNN MARTIN the sum of One thousand pounds and to my cousin ROBERT DEMPSTER of Lauriston Hilbre Road, West Kirby in the County of Chester the sum of Seven hundred and ninety pounds being the amount received on the sale of the house in Douglas Isle of Man which was disposed of by me and of which it was intended he should have the benefit after my death.

I direct my Executor to purchase an annuity of Fifty two pounds on the life of MRS. EMILY MARRIAGE of No. 66. Boyton Road Hoinsey the mother of the said "Sol" Marriage and I declare that such annuity is to be purchased in her name and my Executor is to make the said purchase on such terms as he may consider best in the interests of the said Emily Marriage.

And I declare that all the legacies and bequests hereinbefore contained are given by me free from all duties and that such duties are to be paid out of my estate.

And as to all the residue and remainder of my estate and effects whatsoever and wheresoever both real and personal I give devise and bequeath the same to my Executor upon trust to sell call in and convert into money a sufficient part thereof to enable him to pay my debts and funeral and testamentary expenses and the legacies and bequests hereinbefore bequeathed and all duties and I give devise and bequeath the ultimate residue of my estate and effects to my cousin the said ROBERT DEMPSTER for his own use and benefit absolutely.

For the information of my Executor I desire to mention that a list of my jewellery will be found with my bankers the Clydesdale Bank.

aforesaid Court to THE REVEREND OSWALD LUNN MARTIN of The Vicarage, Earls Colne in the County of Essex, Clerk, the sole executor named in the said Will.

BRITISH JOURNAL OF NURSING:

An item in the "British Journal of Nursing" dated August 1929 is as follows:

"Mr. Frederick Dempster-Smith, of Hotel Victoria, Northumberland Avenue, W.C., and of the Imperial Hotel, Bournemouth, who died on March 25th, left £25,000 to the Governors of St. Bartholomew's Hospital for the endowment of a ward at such hospital to be named and kept in perpetuity as having been founded by me in memory of my late dear friend William James Marriage (Sol), a corporal-major in the Household Battalion, who was killed in France while serving his country in the Great War, such ward to be called the Sol Memorial Ward".
